## Who are CECA Wales?

With the Welsh Government offering clear leadership, teamed with a body which will hopefully provide a vision, a focus and strategic direction for the sector in Wales, this is a golden opportunity to make Wales a more prosperous place to be.

#### Promote the value of infrastructure to the Welsh economy and seek increased investment

- Support the Welsh Government in developing a National Infrastructure Commission for Wales
- Ensuring the construction sector is a key consideration in the development of an investment strategy for infrastructure
- Report on the value of infrastructure investment to the economy of Wales

#### Streamline procurement making the process of bidding for work more efficient and effective

- Work with construction clients to ensure that bidding costs for contractors are minimised whilst maximising value for money for clients
- Report on bidding costs for contractors and the broader industry

#### Attract a diverse and talented workforce to support the sector

- Work with industry partners and stakeholders to promote careers in construction for all
- Increase engagement with younger members

#### Ensure that our workforce is trained and developed to the highest standards

- Develop a CECA Wales training and development programme for members
- Work with government and training providers to develop consistent qualification standards and career pathways for the civil engineering sector

#### Secure the health, safety and wellbeing of our workforce

- Identify and promote good industry practices
- Report on the health, safety and wellbeing of the workforce in Wales

#### How do we make this happen in Wales?

Positive change will not happen through one organisation alone. To achieve the changes that we need we will actively work with others to drive these and other priorities forward. We will:
