Policy & Industry Affairs

Procurement Survey - Frameworks - LAST CHANCE TO COMPLETE

The CECA Procurement Group will publish a research report on frameworks later this year. The aim of the forthcoming report is to further address the challenges our members face when working within frameworks and, as such, to influence policy making. The project is particularly timely given the Crown Commercial Service's forthcoming £30 bn public sector works framework. The survey will help CECA gather anonymised evidence from members in order to strengthen our research and make a compelling case to Government and its agencies for improvement. National Infrastructure Commission - first national assessment

Key points:

- Low carbon energy - making a switch to low-carbon and renewable sources for both the country's power and heating, combined with a move towards electric vehicles, would mean the customer of 2050 would pay the same in real terms for their energy as today
- Digital technology - that the Government devise a National Broadband Plan by Spring 2019, to deliver full fibre connections across the whole of the country, including those in rural areas - this should ensure that the technology is available to 15 million homes and businesses by 2025, 25 million by 2030, and all homes and businesses by 2033
- The future for the nation's roads - that the Government work with councils and private companies to deliver a national network of charging points for electric vehicles and ensures that the impacts of connected and autonomous vehicles are taken into account when planning for the next rail control period and road investment strategy;
- Encouraging growth of cities - that Metro Mayors and city leaders develop and implement long-term strategies for transport, employment and housing in their areas, to support economic growth, with new powers and devolved infrastructure budgets. The National Infrastructure Assessment's spending plans include funding for projects including Crossrail 2 in London, and Northern Powerhouse Rail linking the major Northern cities, and recommends a boost in funding for major cities totalling £43 billion to 2040, with cities given stable five-year budgets, starting in 2021;
- Tackling floods - that the Government should put in place a long-term strategy to deliver a nationwide standard of flood resilience by 2050 with funding for flood risk management increasing significantly over the coming decades
- Cutting waste - that new national rules for what can and cannot be recycled be introduced, with restrictions on the hardest-to-recycle plastics, aimed at increasing rates and reducing the amount of plastics going to incinerators. This would also mean that all food waste is separated making it available to create biogas, so it can be used to heat people's homes and potentially as a transport fuel

Construction profit warnings double in first half of 2018

Twice as many profit warnings were issued by FTSE construction and material companies in the first half of 2018 as in the same period of 2017, according to EY's Profit Warnings Stress Index.

Four companies issued a total of six profit warnings in the first six months of the year.

By the same point in 2017 there had been three profit warnings, which went on to hit seven for the whole year.

.... but construction growth to rebound to 2.3% next year

UK construction output is expected to bounce back to 2.3% growth in 2019 after dipping by 0.6% this year. The growth hiatus this year ends the five-year run enjoyed by the industry, fed mainly by private sector home building and strong commercial and industrial activity.

While forecast 2019 and 2020 growth will boost civils contractors and trade contractors working for house builders, commercial building contractors are expected to continue to feel the squeeze in both commercial and retail work opportunities.

The latest forecast from economists at the Construction Products Association, revises 2018 output down from stagnation to contraction, due mainly to bad weather and the fall-out from Carillion.

Construction self-employment on the rise again

Unite, the union, is sounding a warning after new figures revealed a rise in self-employment. A Freedom of Information request made by Unite to HMRC revealed that 1.12 million construction workers were paid via the Construction Industry Scheme (CIS) in 2017/18 - a 4% increase on the previous year.

CBI report on Government's Brexit White Paper: Construction

While trade in construction products has been addressed, future access to people is a top priority for firms. The White Paper sets out a vision for how the UK and EU can continue to benefit from frictionless, tariff-free trade for manufactured goods, recognising the complexity of long-established supply chains across the continent. Achieving this vision will be especially vital for the construction sector reliant on significant import volumes of the materials and products that underpin virtually every construction project in the UK. But with approximately 9% of the UK's construction sector workforce comprised of EU nationals, there remains a lack of clarity on the ability for firms to access EU national workers once the UK leaves the EU. The commitment to supporting business in moving people between states is welcome, and new arrangements must avoid placing new administrative and costly burdens on businesses - particularly smaller firms. These are issues central to the government's ability to deliver its ambitious housing and infrastructure.

Consultation: National Policy Statement for nuclear power

The consultation on the siting criteria and process for a new National Policy Statement for nuclear power with single reactor capacity over 1 gigawatt beyond 2025 was the first step to designating a new National Policy Statement for Nuclear Power between 2026-2035. The consultation was published on 7 December 2017 and closed on 15 March 2018.

Start date set for £780m East Coast Main Line upgrade

Work will take place over the next few years and will see significant improvements to platforms, tracks, signals and junctions across the route. The government said: 'Together with new Intercity Express Trains on the East Coast Main Line, this will mean passengers travelling on long distance journeys between northern towns and cities will benefit from more seats and faster, more frequent journeys between Doncaster, Leeds and Newcastle.' Upgrade work will start next year and be completed in the early 2020s.

Update on Southampton to London pipeline project announced

Esso Petroleum Company Limited has announced that it will publish and consult on its preferred route for the proposed Southampton to London Pipeline Project in the autumn. The project proposals are to replace 90km of Esso's 105km aviation fuel pipeline that runs between the Fawley Refinery and Esso's terminal storage facility in Hounslow, London. The project meets the threshold for a Nationally Significant Infrastructure Project (NSIP) set out in the Planning Act 2008 and will require development consent to authorise its construction and operation. Esso has published a project development timeline for the project which was initially launched in late 2017.

Winners named on £500m Midlands highways framework

Balfour Beatty, Eurovia, Galliford Try and Morgan Sindall were chosen for the Midlands Highways Alliance MSF3 framework, which will cover highways improvements, maintenance and infrastructure works for the next four years.

The MSF3 framework replaces the Midlands Highways Alliance's MSF2 framework, which ran for four years to June 2018.

Balfour Beatty and a Galliford Try / Aggregate Industries JV were among the firms on MSF2's highest-value lot for projects up to £25m, alongside a JV between Tarmac and collapsed contractor Carillion. Aggregate Industries, Balfour Beatty, Eurovia, Galliford Try and Tarmac / Carillion were all on MSF2's lower-value lot for projects up to £5m.

HS2 civils start delayed another three months

HS2 has pushed back the start date for its civils work, with construction now expected to commence more than seven months later than originally planned.

The Department for Transport confirmed that the notice to proceed for the £6.6bn civils deals had been moved from the start of March to June to give contractors more time to finalise their designs.

This is HS2's second change to the notice to proceed, with work having originally been scheduled to begin in November this year.

More than 100 potential partners express interest in Heathrow's third runway

On 25 June 2018, MPs cleared the way for the £14bn expansion of Heathrow and now the airport is ramping up its search for partners to accelerate innovation.

Airport bosses say they have received more than 100 expressions of interest from companies looking to share ideas with Heathrow around sustainability, service innovation, building design, cost efficiencies and commercial concepts after it launched the invitation to businesses in April.

It's all part of efforts by Heathrow to ensure that the construction of the north-west runway is "more efficient, sustainable and affordable". The list of proposals being taken forward will be announced in late August, while the remaining potential innovation partners will be invited to submit a business case and implementation plan to demonstrate the feasibility of their ideas.

Cost of industry skills cards set to rise in September

The cost of skills card issued by the Construction Skills Certification Scheme is set to rise to £36 from September. The 20% rise from the current rate of £30 is the first increase for eight years and applies to all cards administered directly by CSCS.

IPA: more major projects to be delayed or scrapped

The Infrastructure and Projects Authority (IPA) has released its report which highlights how the number of planned projects which appear to be unachievable and given a red warning has doubled from the four recorded last time. Including those with amber/red warnings for projects deemed to be at risk then the figure rises to 46 - 8 more than last year.

Furthermore, statistics show that only 18 new projects were added to the portfolio in 2017-18, which is the lowest number since the IPA started publishing its annual report six years ago - 50% less than the number added in 2016-17.

- 'bytes and mortar' revolution to use digital design and offsite manufacturing to transform building construction
- landmark deal will boost the delivery of government's ambition to deliver 1.5 million new homes by 2022
- deal will support Clean Growth Grand Challenge mission to halve the energy use of new builds by 2030, helping families reduce their utility bills

NEC4 Alliance Contract opens door to increased collaboration

The much-anticipated NEC4 Alliance Contract has now been published, allowing parties to construction projects to collaborate more closely and equally share in that project's risks and rewards. The Alliance Contract is the last outstanding piece from the fourth edition of standard form New Engineering Contracts produced by the Institution of Civil Engineers, following the publication of the rest of the NEC4 suite in June 2017.

Northern transport spending 'outdo the South' - DfT

Transport spending in the North will be higher than in London and the South over the next three years, according to new figures. The Department for Transport's analysis of future investment show that between 2018 and 2021, it will be investing £831 per head on road and rail upgrades in the North East, North West and Yorkshire - more than £30 more per head extra than London and the South at £799.

The government's National Living Wage (NLW) is the minimum pay per hour most workers aged 25 and over are entitled to by law. The rate will depend on a worker's age and if they are an apprentice. HMRC (HM Revenue & Customs) can take employers to court for not paying the MW/NLW.

Peel pushes on with Protos energy-from-waste plant

Peel and operator Covanta are set to press forward with an energy-from-waste facility at Protos energy park, the 126-acre site formerly known as Ince Park.

Peel first received consent for a 95-megawatt Refuse Derived Fuel plant in 2009; the consent has since been implemented through the construction of an acoustic fence, but the plant itself has not been built out. Peel's intention is now to develop a smaller energy-from-waste plant instead of the larger RDF plant having received planning consent for the EfW site on Plot 8 of Protos in 2017.

Cuadrilla becomes first in UK to receive final fracking consent

Cuadrilla has received final hydraulic fracture consent from the Department for Business, Energy & Industrial Strategy, for its first horizontal shale gas exploration well at Preston New Road in Lancashire.

Manchester City Council launches £140m small works programme

Manchester City Council has started the search for contractors to deliver a four-year, £140m small works framework, covering projects across both Greater Manchester and the North West of up to £500,000 in value. Set to be procured across two lots - one covering projects up to £100,000, and the other for projects ranging between £100,000 and £500,000 - the framework will be for an initial three years, starting next year, with the option to extend for another year.

Projects under the framework cover a wide range of sectors and disciplines, including new-build construction, refurbishments, modular buildings, mechanical & electrical, and refurbishments.

Liverpool Lime Street reopens after eight-week closure

Train services to and from Liverpool Lime Street have restarted after an eight-week programme of works to upgrade and lengthen platforms at the station. The upgrade works, which have been ongoing for nearly nine months over various closures, have now largely completed and have delivered remodelled, lengthened and widened platforms to provide more space for trains and passengers. The latest set of works began on 2 June. The latest upgrade works provided upgrades to platforms 1 and 2. Two more days of works - Sunday 2 September and Sunday 14 October - are needed before platforms 1 and 2 come into public use, but once complete, these will allow an extra three services per hour in and out of the station, including direct services to Scotland.

Metrolink extension work begins at Trafford Centre

Track laying for the Metrolink's Trafford Park Line has started at the Trafford Centre, the final stop on the £350m light rail extension. The Trafford Park Line is due to open in 2020 and will add a further 5.5km and six stops to Metrolink, already the UK's largest light rail network. The line is being funded by Greater Manchester's devolution deal, which was signed by the city-region's leaders in 2014. Trafford Council is providing £20m towards the project.

900,000 sq ft for Amazon in St Helens?

The online retail giant is understood to be close to agreeing a deal on a 360,000 sq ft unit at Bericote's M6Major.com development in Haydock.

Bericote was given outline consent in early 2017 to develop up to 1.4m sq ft in two units at the 91-acre site, which was formerly known as Florida Farm and lies opposite the existing Haydock industrial estate at junction 23 of the M6. However, it has in the last month submitted reserved matters applications to St Helens Council for two units totalling just under 900,000 sq ft.

Cash injection for Northern Powerhouse as Cabinet visits North East

- £780m investment in East Coast Main Line to be confirmed - giving passengers more seats and faster, more frequent journeys
- Government will lay legislation to make £600m North of Tyne Devolution Deal a reality - giving people of Newcastle, North Tyneside and Northumberland a real say in their future

Rochdale flood defence scheme secures £5m funding

A £46m project to protect up to 1,000 homes in Rochdale and Littleborough is set to start next summer after the Government confirmed a £5m funding package.

The scheme, supported by the Environment Agency and Rochdale Council, will see storage reservoirs built along the River Roch and its tributaries from Littleborough to Rochdale town centre.

It also includes other flood alleviation measures, such as raised walls, and improvements to bridges and culverts, across Green Vale Brook, Town House Brook, and Buckley Brook

Skelmersdale town centre regeneration secures funding

West Lancashire Borough Council, St Modwen, and Homes England have agreed a funding deal to deliver the £19m first phase of the regeneration of Skelmersdale town centre.

At a council meeting on 18 July, the council agreed to invest in the scheme to enable delivery of the first phase, which is expected to start in early 2019 with an 18 month build programme.

This will include a 20,800 sq ft Lidl store, and a 20,000 sq ft B&M, as well as further units, for a total of 50,000 sq ft of retail space.

The first phase is expected to cost £19m and is being funded by the council, along with a contribution from Homes England, while St Modwen will act as designer and developer.

Royal Mail takes largest unit at next phase of Omega

Royal Mail has agreed a pre-let for a 346,000 sq ft unit at the next phase of Omega Warrington, due to complete construction later this year, at a new headline rent understood to be £6.25/sq ft.

Mountpark Logistics is forward-funding the development at Omega South, which features 750,000 sq ft of warehouses across three units, and Royal Mail is understood to have signed a deal to take the largest, totalling 346,000 sq ft.

Two other units of 137,000 sq ft and 97,000 sq ft are also being delivered, with construction due to complete in November 2018. A fourth unit, totalling 184,000 sq ft, also has planning consent and will follow as a second phase.

Planners appointed to shape Liverpool gateway masterplan for £2bn scheme

A 'super team' of planners has been appointed to develop a masterplan for the regeneration of the gateway site to a £2bn flagship scheme in Liverpool. After a major tendering exercise, Liverpool City Council has chosen a consortium of three companies to independently develop a Spatial Regeneration Framework (SRF) for the Knowledge Quarter Gateway (KQG), which covers more than 56 acres within the city centre.

Plans submitted for job-creating rail-connected hub

Harworth Group has submitted plans for the transformation of a former Yorkshire colliery site into a major rail-connected hub that will incorporate two million sq ft of employment space and support up to 2,000 new jobs. The land regeneration and property investment specialist has submitted an outline planning application to Selby District Council to transform its Gascoigne Wood site in Sherburn-in-Elmet, North Yorkshire.

Balfour Beatty starts on £11m Birchwood Park road improvements

Work has started on an £11m package of road improvements around Birchwood Park in Warrington, due to complete in December 2019.

Steel works redevelopment set for green light

A hybrid planning application for the major redevelopment of a former steel works in Sheffield has been recommended for conditional approval. The application concerns part of the former Outokumpu works, an almost 50-acre brownfield site on land off Shepcote Lane which closed in 2005 and was cleared in 2011. Peel Logistics Property intends to develop a new flagship prime logistics park at the location. It is proposed that there will be two phases of development for the construction of up to about 838,000 sq ft of industrial, distribution and office uses.

Government announces new Northern Powerhouse body - NP11

Local Enterprise Partnerships in the North of England will form an influential new body to support the government's ambitions for the Northern Powerhouse across the region. The Chairs of each of the 11 Local Enterprise Partnerships (LEPs) will sit on a newly formed, government-funded board called the 'NP11'.

The board will act as one voice representing each of their regions as a modern day 'Council for the North' to work with and advise the government on issues such as how to increase productivity, overcome regional disparities in economic growth and tackle the historic north-south divide.

New body launched to spearhead rail leadership in the north

Northern Rail Industry Leaders (NRIL) brings together businesses to help develop and support the rail industry in the region. By providing leadership and industry expertise, the group is defining, shaping and delivering a journey of success for the North.

First step for multi million pound Cumbrian coastal railway upgrade

The first steps have been taken to begin a multi-million-pound upgrade of the under-pressure Cumbrian coastal railway line. An initial business case has been submitted to the Department for Transport to improve the line, which connects Barrow to Carlisle. The Cumbrian Rail Programme Board - a group of businesses and organisations - says pressure on the line will significantly increase over the next 10 years.

£85m Stockport Interchange clears first hurdle

Plans to build a bus station below a new park in Stockport have been cleared by the Greater Manchester Combined Authority. As well as a two-acre public park above the interchange, the proposals include a 15-storey private rented block of flats and upgrading a section of the Trans Pennine Trail alongside the River Mersey. Details of the project are now out to consultation ahead of a planning application being submitted to Stockport Council later this year.

If approved, enabling works are set to start by autumn next year with a main construction contract awarded in early 2020. Around £45m has been earmarked for the interchange, with the residential block expected to cost a further £40m.

Option for underground station at Manchester Piccadilly

An underground station accommodating high-speed rail services as well as Northern Powerhouse services could be built at Manchester Piccadilly. Rail Minister Jo Johnson said in a Commons Written Reply to Mike Kane (Labour, Wythenshawe and Sale East): "The Department is working with Transport for the North, Manchester City Council and Transport for Greater Manchester to explore ways to integrate Northern Powerhouse Rail into an HS2 station at Manchester Piccadilly."

East Lancs railway extension back on the table

Network Rail is to draw up a feasibility study to extend the East Lancashire Heritage Railway from Heywood to Castleton, nearly 10 years after the proposals were first put forward. The proposals to extend the railway between Heywood and Castleton were first mooted by the East Lancashire Railway Trust in 2009, as part of a plan for the railway's future to 2020.

Greater Manchester to create UK's biggest cycling and walking network

Greater Manchester's cycling and walking commissioner Chris Boardman has unveiled plans for 1,000 miles of interlinked bike and walking lanes across Greater Manchester. The 'Beelines' network will see £1.5bn invested over ten years and will include 75 miles of segregated cycle lanes like those found in Holland and Denmark

Beelines will be the largest joined-up system of walking and cycling routes in the UK and has been developed with all ten Greater Manchester local authorities. Once built, the network will better connect every community in Greater Manchester, benefitting 2.7 million people and making cycling and walking a real alternative to the car. The proposals also include plans for 1,400 safer road crossings on the majority of routes and 25 'filtered neighbourhoods', where priority will be given to the movement of people and where more public spaces to sit, play and socialise will be created.

Graham wins £90m Congleton link road

Cheshire East Council has appointed Graham Construction to deliver the Congleton Link Road scheme - which could begin construction later this year. The 5.5km road will unlock key sites for housing and employment and provide an economic boost to Congleton, relieving traffic congestion in the town centre and improving east-west connectivity. The Jacobs designed single carriageway road will run to the north of Congleton between the A534 Sandbach Road in the west and the A536 Macclesfield Road in the north east.

Plant hire pressure in NW as smart motorway schemes ramp up

Contractors are facing rising plant hire rates across the north west as four smart motorways worth around £500m are due to start within the next 18 months.
