Major contractors warned again over late payment work ban

Cabinet minister Oliver Dowden has fired another warning at major contractors over late payment. Dowden reiterated the government's get-tough stance at the RICS annual Construction Conference. September will see new rules introduced meaning large companies could be prevented from getting major government contracts if they do not pay 95% of their invoices within 60 days.

Kerslake commission: Create regional agencies to boost infrastructure

Four new economic development agencies are needed to oversee infrastructure projects and regional development, an independent review of inequality in the UK will recommend.

The UK2070 Commission, established last year to examine inequalities across different parts of the country and chaired by former head of the civil service Lord Bob Kerslake will recommend the creation of the new bodies. Lord Kerslake's commission will say that an agency for each of the North, Midlands, South-east and South-west of England would help to stimulate growth.

HS2: 9,000 jobs created to date

HS2 is already supporting 9,000 jobs around the country. Over 2,000 firms across the UK now have contracts with HS2, 70% of them SMEs. At peak construction, over 30,000 people will be needed to design and build the railway.

CPA: Warning of construction impact from British Steel liquidation

Construction industry figures have warned of the impact British Steel's liquidation could have on the sector after the steel giant was wound up at the High Court.

The Scunthorpe and Teeside-based manufacturing business continues to operate under official receivership while attempts are made to search for someone to take over the company.

Construction Products Association economics director Noble Francis said the impact on the sector is not going to be felt immediately but warned that the sector may become reliant on imports in future.

Network Rail seeks digital partner in potential £180m eight-year deal

Network Rail has launched the third procurement in its major digital railway transformation programme on the East Coast Main Line (ECML) - a potential eight-year deal worth £180m.

The company is seeking a traffic management partner to work within its London North Eastern and East Midlands (LNE & EM) route on the first inter-city development and deployment of modern in-cab signalling. The traffic management system will be the first tailored system on the network designed and developed in conjunction with industry partners, reflecting a new way of working for Network Rail.

£55m Homes England grant funding to boost development of 4,000 homes

Homes England has agreed funding deals with 12 local authorities to deliver 4,000 homes across England. The £55m funding has been awarded through the government's £450m local authority accelerated construction (LAAC) programme, and will support local authorities with works required to prepare their sites for the development of new homes such as infrastructure enabling works, planning and technical expertise and site remediation. In the north, the local authorities are: City of York Council, Gateshead Council, Newcastle City Council, Pendle Borough Council, and High Peak Borough Council.

Social Enterprise UK report: Social value-led procurement driving higher economic growth

A new report, Front and Centre: Putting Social Value at the Heart of Inclusive Growth, launched by Social Enterprise UK, has found that local councils are increasingly using procurement as a way to drive higher economic growth.

The report calls on central government, local councils and other public bodies to do more to utilise social value, putting it front and centre of decision making. Based on in-depth research across local government, the report shows a growing use of social value - making spending decisions not just on financial cost but on the economic, social and environmental impact.

82% of local councils believe that spending public money focusing on social value, rather than just focusing on the cheapest product, generates higher levels of growth. Sunderland, one of the case studies referenced in the report, was one of the fastest growing cities in the UK in 2018. Two-fifths of councils also believe that a social value approach can reduce inequalities.

Work starts on £1bn Ford Dagenham regeneration

Developer Countryside Properties and London & Quadrant Housing Trust plan to transform the 29-hectare old Ford Dagenham plant into a major new community of over 3,000 homes.

It is the second largest housing scheme in UK to gain planning permission last year, and one of only three regeneration schemes in London delivering so many homes.

The first phase of the Beam Park development will deliver 640 new homes, as well as the Beam Park railway station.

ICE report: Infrastructure project final costs average 80% above bid prices

Recommendations:

- Infrastructure owners should complete scope, design and exploration before work starts to avoid scope creep or retroactive changes, taking steps to include contractors in design at an early stage.
- The Government and infrastructure owners must move away from capital cost as the most important metric when assessing project benefits, and recognise the importance of whole-life economic, social and environmental value.
- All public infrastructure owners undertaking procurement must award contracts based on a cost estimate range, using a should-cost estimate as a reference point, with an amount of contingency allocated appropriate to the level of project maturity.
- Principles set out in the Government Outsourcing Playbook should be mandatory for infrastructure owners, this includes infrastructure owners undertaking should-cost modelling to help inform their expectations and knowledge of appropriate tender prices during the procurement process.

Network Rail appoints first regional MDs

Network Rail has appointed its first five regional managing directors ahead of a major restructure. Changes for the operator include devolving responsibility for the company into five regions, containing 13 routes. Four of the five new MDs are already working at Network Rail, while the incoming head of the North West and Central region is Tim Shoveller, who joins from Stagecoach.

Environment Agency calls for new approach to flood and coastal resilience

Launching a major, long-term strategy to tackle flooding and coastal change, Environment Agency chair, Emma Howard Boyd has said “we cannot win a war against water” by building higher flood defences and called for a new approach to ensure communities are resilient to the threat of flooding posed by climate change. Opening an eight-week consultation on the new strategy, Howard Boyd said that the Environment Agency is preparing for a potential 4°C rise in global temperature and urgent action is needed to tackle more frequent, intense flooding and sea level rise.

Among the recommendations in the strategy, the Environment Agency has committed to working with partners to develop consistent standards for flood and coastal resilience across the country. To achieve these standards, communities should have access to a range of tools which give them control of how they prepare for and respond to flooding and coastal change, based on the challenges or flood risk any location may face.

These could include traditional defences, temporary barriers, natural flood management, sustainable drainage systems, effective flood warnings and emergency response, alongside designing and adapting existing properties and new development so they can recover quickly from a flood.

Site inductions to contain modern slavery warnings

Major contractors are now highlighting how to spot signs of modern slavery and labour exploitation as part of site induction talks. Leading firms have teamed up with the Gangmasters and Labour Abuse Authority (GLAA) for the initiative: <https://www.gla.gov.uk/>

The package includes a presentation for new starters which will be shown at the end of traditional health and safety inductions. Other initiatives include complementary posters on spotting the signs of exploitation and a toolbox talk aimed at raising awareness of workers' rights on site.

The move is part of the Construction Protocol launched by the GLAA and signatory firms to protect vulnerable workers, share information and raise awareness within supply chains.

Armitt demands Chancellor commits to funding infrastructure plan

National Infrastructure Commission Chair Sir John Armitt has called on the Chancellor to commit to a major programme of upgrades of transport, energy and technology networks. Sir John is concerned that the Government is set to only pay lip service in the forthcoming Autumn spending review to the country's first National Infrastructure Assessment published last year. The government is required to consider the plan and formally respond with its own strategy, expected to be announced this autumn.

Sir John's key tests set out in the letter to the Chancellor

- Long term perspective - the strategy must look beyond the immediate spending review period and set out the government's expectations for infrastructure funding and policy up to 2050
- Clear goals and plans - where the government endorses NIA recommendation, this should be backed up with a specific plan, with clear deadlines and identified owners
- Firm funding commitment - the government should commit to providing funding of 1.2% of GDP a year in infrastructure
- Genuine commitment to change - recommendations such as devolving funding for urban transport to cities and a national standard for flood resilience are fundamental policy changes, and "the strategy needs to respond in the same spirit."

FIDIC launches The Emerald Book

International engineering federation FIDIC (the International Federation of Consulting Engineers) and ITA-AITES (the International Tunnelling and Underground Space Association) have teamed up to publish a new form of contract for tunnelling and underground works, The Emerald Book.

Construction industry blames auditors for Carillion's collapse, says new report

A survey of the supply chain conducted by public sector procurement specialists Scape Group has found that "93% of suppliers think the relationship between Carillion and KPMG enabled the outsourcer's true financial position to be concealed." Over half of suppliers polled think the accounting policies at Carillion were "not discharged in good faith" and that the subsequent collapse was "facilitated by poor management." 64% of suppliers believe that Carillion's downfall was due to "debt mismanagement, acquisitions and long payment terms, created by a focus on revenue rather than profit." The survey also claims the construction industry would "support a shake-up of the 'big four' accounting firms, with 57% of suppliers polled saying they thought this was required."

Digital UK map of buried utilities

Work is starting on an ambitious project to draw up a digital map of all UK underground pipes and cables to end strikes and save workers lives. The government's Geospatial Commission plans to collate existing data on underground pipes and cables to create an Underground Assets Register. Nearly £4m is being invested in London and Sunderland to test the feasibility of the project. There is currently no comprehensive underground map of the UK's service network.

Network Rail £750 million signalling contract

Network Rail has announced five-year contracts worth an estimated £750m to deliver signalling and telecoms across the country in period CP6, between 2019-2024, with further contracts set to be awarded in June 2019 and January 2020.

The signalling and telecoms (S&T) frameworks, which are split into six geographical lots, have been awarded to VolkerRail Special Businesses Ltd (London North West), Atkins Ltd (Anglia, South East and Wessex), Linbrooke Services Ltd (London North East), Babcock Rail Ltd (Scotland), Colas Rail Ltd (Western) and Siemens Mobility Ltd (Wales).

The frameworks will deliver projects of varying value, including stand-alone level crossings, stand-alone major telecoms and related civils works.

Rail firms call for independent body to oversee Britain's rail network

Rail companies have today called for a new independent non-government body to oversee Britain's rail network. The Rail Delivery Group (RDG) has described its proposals as a golden opportunity to "call time on short term fixes and set out the once-in-a-generation system upgrade the railway needs if it is to help the country prosper over the next 25 years." They also claim their plans would "better join up the railway, improve accountability for passengers and result in easier, better value fares for all."

CITB Business Plan reveals spending proposals for £614m of levy cash

The Construction Industry Training Board is planning a new "big, bold" careers campaign in a bid to attract a new generation of workers into construction.

The move is part of the board's latest three-year plan which highlights how it will spend the £614m of levy income collected between 2019/20 to 2021/22.

The plan outlines the 'Big Six' skills challenges identified by CITB research. They include:

- making construction an attractive career to a broader range of recruits
- developing a 'site-ready' workforce
- getting more construction learners to join the industry
- growing the number and diversity of apprentices
- helping smaller firms invest in the training that can transform their business
- boosting the number of assessors for vocational qualifications

CMA guidance on competition law for the construction industry

The Competition and Markets Authority has recently been investigating a number of cases of potential competition law breaches by firms in the construction sector. Most recently, their investigations resulted in the disqualification of two company directors of CPM group due to their involvement in a cartel. To raise the level of awareness within firms about competition law and the rules with which firms have to comply, the CMA has launched a package of materials to help business. This includes:

ICG lead drive to eliminate site accidents

Major clients are joining forces to push for a step change in the safety, health and wellbeing of everyone involved in big UK infrastructure projects. Over the next 12 months representatives from the industry's major clients, contractors and supply chain have agreed to work together to tackle the causes of illness and injury in the sector. The initiative has been driven by the Infrastructure Client Group (ICG), which represents some of the country's largest client organisations.

ICG members include EDF Energy, Environment Agency, Heathrow, Highways England, HS2, National Grid, Sellafield Ltd, Tideway and Transport for London.

Social value model developed for UK government procurements

Potential social benefits that can be derived from UK government contracts will need to be considered by departments when they set criteria for the award of those contracts, under new proposals outlined by the government. The government's draft new social value delivery model sets out policy outcomes based on broad 'social value' themes that departments can strive for when developing award criteria for their contracts.

Network Rail to keep retentions ban after restructure

Network Rail will retain its ban on retentions and enforcement of 28-day payments among suppliers after its restructure, the rail body has said. Chief executive Andrew Haines said that most contractors won't have to duplicate their work five times under the new structure.

CITB forecast: 168,500 new jobs to be created over next 5 years (15,250 in the North West)

A five-year forecast into the industry's skills needs published by the Construction Industry Training Board (CITB) has shortened expectations for growth with infrastructure predicted to grow by 1.9%, down from 3.1% in last year's forecast.

North West - and the North

Green light for £1 billion trans-Pennine transformation

Options for the transformation of a key northern route, improving connections between the east and west of England were unveiled by Transport Secretary Chris Grayling. The A66 is both a nationally important road, linking Penrith in Cumbria with Scotch Corner in North Yorkshire and a key regional route. It is a hugely important route for freight traffic across the United Kingdom and as the main link to the Lake District and North Pennines to the East of England.

Upgrading the A66 route will provide enormous benefits to people living locally but will also change the way people travel round the UK, improving connections from Scotland to the east coast of England and Belfast's port traffic, via Stranraer, onwards to ports including Hull and Felixstowe.

Highways England is now developing plans to fully dual the remaining single carriageway sections of the A66, which total 18 miles of the 50 mile route and this is the first opportunity for members of the public to get involved. The consultation sets out ideas for each of the remaining sections of single carriageway. They include:

- Allowing through traffic from the M6 or the North East to bypass congested Kemplay Bank Roundabout
- Dualling the existing three-mile section between Penrith and Temple Sowerby including a new junction arrangement for Center Parcs at the western end and an optional short bypass to avoid High Barn at the eastern end
- A new bypass north or south of Kirkby Thore and north of Crackenthorpe - following the route of the old railway line or the old Roman road
- Providing an upgrade of the five-mile single carriageway between Appleby and Brough - freeing up the existing A66 for local access-only traffic as well as walkers, cyclists and horse riders
- Re-designing and improving the junction with the A67 at Bowes to allow full westbound and eastbound access and exit to and from a newly dualled 1.9-mile section of the single carriageway
- Dualling the existing road between Cross Lane and Rookley with options for a short bypass of St Mary's Church and Old Rectory at the eastern end of the 1.8 mile section
- Similarly, dualling the existing four mile section between Stephen Bank and Carkin Moor but with three different options, including short bypasses - for the eastern end

The project, which would see a road link being built from Heysham to south Cumbria via the Furness Peninsular and then crossing the Duddon Estuary, is being driven by the Northern Tidal Power Gateways board headed by Chief Executive Alan Torevell. He will present the project and the latest details to businesses at a Tidal Power Business Forum at Kendal Town Hall on **7 June 2019**.

Aviation strategy integral for Northern UK to ensure global position

The UK government must establish northern airports as the 'beating heart' of Northern Powerhouse as leaders stress the importance of global connectivity in the transport sector. They said that direct access to the world's most important economies is critical to the creation of internationally significant centres of excellence in fields like advanced manufacturing, technology,

Enterprise Zone plans lodged in Blackpool

Outline proposals have been submitted for a first, 81-acre phase of development at Blackpool Airport Enterprise Zone, including close to 1m sq ft of industrial space, a sports village and a gateway access road. The zone overall is to see 356 acres developed out over time, with £28.8m allocated to tackle this initial three-year phase. Preston-based architect and planner Cassidy + Ashton is working on behalf of the site's promoters, Blackpool Council and Fylde Borough Council. The phase one site sits in the south eastern part of the zone, mostly within Blackpool's jurisdiction. Cassidy + Ashton's plan sets out the relocation of the existing Common Edge football pitches, including new facilities for AFC Blackpool, to unlock land for industrial development. Up to 25 parcels of serviced land could be brought forward during phase one, completing by 2023. Amy Johnson Way on the existing business park will be linked to the new spine road by a roundabout providing access from Common Edge Road, Marton before it meets Queensway.

Merseytravel reveals £250m framework winners

Companies including Pell Frischmann, IBI, Waterman, Aecom, and Arup have secured a place on a framework covering disciplines such as engineering consultancy, transport planning, quantity surveying, and architecture. The framework will cover a vast range of disciplines needed across Merseytravel's estate, which includes its offices, bus stations, ferry terminals, and tourist attractions including Spaceport. It also includes the Kingsway and Queensway Mersey tunnels.

Sellafield awards 20-year contracts worth up to £7bn

Sellafield has awarded contracts to four firms to carry out decommissioning work at its Cumbria site over the next two decades. According to Sellafield, the total programme and project procurement value has an expected range of £3bn-4bn but could end up being worth as much as £7bn. Morgan Sindall has been named civils construction management partner and said its deal was worth an expected £1.6bn. Doosan Babcock has been appointed as the process construction management partner. Wood was awarded the design and engineering partner role with KBR appointed as the integration partner. The decommissioning programme is expected to last for 100 years at the Cumbria site, which ranges over two square miles and contains more than one thousand buildings.

Economic and green boost for Peak District as £14m rail freight scheme unveiled

Network Rail has transformed a disused council tip at Buxton into 430 metres of railway sidings so longer freight trains can serve local quarries.

New £2bn civils framework for Yorkshire & the Humber

A new £2bn civils framework covering Yorkshire and the Humber has launched a call for tenders.

Local authorities in the region have committed to procuring major civil engineering projects worth more than £10m each through the new framework.

The launch was prompted by the success of the £1bn YORcivil 2 framework, which went live in 2017.

A spokesman for East Riding council, which is procuring the new framework, said lots on YORcivil 2 for schemes worth more than £10m had already hit their value limits, which created the need for an additional framework covering major projects.

Schemes expected to be procured through the new deal include maintenance and construction of roads, bridges, flood alleviation schemes and public realm.

The framework will run for an initial four years with the possibility of extension for a further two years.

The deadline for tenders is early June and eight contractors will be appointed in September.

Northern Powerhouse Rail set for autumn decision

Chancellor Philip Hammond told the House of Commons treasury committee that the next Spending Review - expected in the autumn - would have a "laser focus" on improving regional productivity, with the modern industrial strategy "at the heart" of the plan.

Go-ahead given to acquire land for important Lancashire road scheme

The proposed scheme, which will link the west side of the city to the M55 motorway, is the biggest new road programme in the Preston, South Ribble and Lancashire City Deal.

Cheshire East to green light £59m Middlewich bypass

The 1.7-mile road, designed to unlock major employment sites to the south of the town centre, could get under way in 2020 with Cheshire East Council to sign off the latest stage of the project.

The proposed road, valued at around £58.5m, will run from the Salt Cellar roundabout on the A54, to Booth Lane, south of Middlewich. The single carriageway road is expected to unlock significant amounts of housing and employment land south of the town.

Network Rail: five year £5.7bn investment in LNW

Just days before Network Rail enters its next five-year funding cycle, its London-to-Carlisle region has unveiled a £5.7bn plan to keep services running smoothly along Europe's busiest mixed-used railway. The London North Western (LNW) region runs the railway infrastructure in the Chilterns, West Midlands, North West, Merseyside, Lancashire and Cumbria - accounting for 24% of the country's railway network. The West Coast main line which features prominently in the network connects main cities like London, Birmingham, Manchester, Liverpool and Glasgow.

In its funding package for the five years to 2024, government has given LNW, otherwise known as the "backbone of Britain", £5.7bn for its vital operations, maintenance and renewals activities supporting the region's business vision of "one team delivering brilliant service for customers and taxpayers." Money within that funding pot will go towards railway renewals (replacing track, bridges, points, embankments and structures), major resignalling and track remodelling at Crewe on the West Coast main line and the delivery of HS2.

One NW site shortlisted for regional Heathrow construction hub

Heathrow Airport has revealed 18 sites left in the running to become construction hubs for the third runway project, one of which is in the North West: Mckeating (East Coast West Cumbria Ltd), Lillyhall Industrial Estate, Workington.

Department of Transport to invest £53m in North West roads

The Department of Transport have revealed that some £53m is set to be invested in the North West's roads, with Lancashire to receive the fourth-highest amount of funding per 1,000 people in the region. Following the announcement of the Budget, drivers and cyclists will be encouraged to see that the extra £53m from the DfT will be committed to road repairs across the North West.
