Construction firms fined £36m for breaking competition law

The Competition and Markets Authority (CMA) has issued three firms with fines totalling more than £36m for breaking competition law by being part of an illegal cartel supplying concrete drainage products for building projects. Northern Ireland-based firm FP McCann Ltd is facing a fine of more than £25m for its part in the scheme. Derbyshire-based Stanton Bonna Concrete Ltd is due to pay more than £7m, and Somerset-based CPM Group Ltd are due to pay £4m. The fines have been imposed after the CMA found that the companies broke competition law by taking part in an illegal cartel covering the UK. From July 2006 to March 2013, they agreed to fix or coordinate their prices, shared the market by allocating customers and regularly exchanged competitively sensitive information (see page 9 for guidance).

Hinkley Point first site hit by freelance tax changes (IR35)

The £22bn Hinkley Point C new nuclear power station site is one of the first major testing grounds for looming freelance tax rules. HMRC IR35 rules are changing next April making contractors liable for determining the tax status of off-payroll professionals. IR35 is legislation that allows HMRC to collect additional payment where a contractor is an employee in all but name. If a contractor is operating through an intermediary, such as a limited company, and but for that intermediary they would be an employee of their client, IR35 kicks in.

Smart motorways review announced amid safety fears

Transport secretary Grant Shapps has announced a review of smart motorways. Mr Shapps told the House of Commons that the Department for Transport (DfT) would carry out a review of the safety of smart motorways, amid fears over the risks posed to motorway users involved in vehicle accidents and breakdowns. The announcement followed comments from Highways England chief executive Jim O'Sullivan, who said the organisation would not be building any more smart motorways with a dynamic hard shoulder, because drivers found the system too complicated.

Time limited: Oakervee HS2 review?

The Oakervee review, announced in August, is assessing factors that include whether the project should continue, its costs and the route it should take. It was initially stated that the review would take six weeks, but the government has since said it may not publish a report until the end of the year. During a debate on alternative routes for phase 1 and 2a of HS2 in parliament this morning, Conservative MP and critic of the project, Michael Fabricant, claimed Mr Oakervee told him the panel was not being given enough time to consider alternative routes.

HS2 streamlines procurement process for subcontractors with standardised PQQ

HS2 has announced it has streamlined the procurement process for subcontractors working across its four main civils contracts. The joint ventures working on the major rail scheme have created a standardised pre-qualification (PQ) process. Subcontractors bidding for work will only need to undergo one PQ process to bid for on different parts of the route.

Joint ventures Balfour Beatty / Vinci / Systra (BBV), Bouygues / VolkerFitzpatrick / Sir Robert McAlpine (Align), Costain / Skanska / Strabag (SCS Railways), Effiage / Kier (EK) worked together as part of HS2's Collaboration Hub to develop the system designed to avoid duplication and cut costs.

Build UK, the Civil Engineering Contractors Association and High-Speed Rail Industry Leaders Group (HSRIL) also assisted in creating the new standardised PQ (called the Common Assessment Standard).

....and HS2 Leeds route could go via Manchester to save £10bn

A plan for direct train links between Manchester and Leeds is being considered as part of the Oakervee review of HS2. Trains from London would run through Birmingham to Manchester and then to Leeds, creating a journey time between Manchester and Leeds of just 20 minutes. The plan is an alternative to the proposed HS2 route, which splits into east and west legs after Birmingham. The eastern line, which goes to Leeds via Toton, a new station between Nottingham and Derby, is at risk of being dropped, saving up to £10bn. Northern Powerhouse Rail, a proposed network of new and upgraded lines billed as “the region’s single biggest transport investment since the Industrial Revolution”, would also be reduced in scope as the direct link from Manchester to Leeds replaces part of it. According to sources close to the HS2 panel, led by the former HS2 chairman Douglas Oakervee, the proposal is “one of 13” options being considered.

Changes to PWLB borrowing will affect local authority housing infrastructure financing

Local authorities are likely to seek alternative sources of finance for new infrastructure or housing following the increase to the cost of borrowing from the Public Works Loan Board (PWLB).

The UK Debt Management Office (DMO) has increased the margin charged on local authority PWLB borrowing by one percentage point for new loans from 9 October 2019.

Bury firm announces plans for Europe’s first ‘liquid to gas’ cryogenic battery

British battery pioneers plan to build Europe’s largest energy storage project using a cryogenic battery that can store renewable energy for weeks rather than hours. The device will be built on the site of an old fossil fuel plant near Bury to power up to 50,000 homes for up to five hours.

Unlike traditional lithium-ion batteries, which typically store electricity for a few hours, the “cryobattery” will be able to store energy for months. The UK’s first full-scale cryobattery, developed by Highview Power, uses renewable electricity to chill air to -196C, transforming it into a liquid that will be stored in large metal tanks. When renewable electricity levels are low the liquid can be turned back into gas, which is used to turn a turbine and generate electricity - but without burning the gas and releasing emissions. Highview Power claims its cryobattery will be the largest project in Europe capable of long-term energy storage. The full-scale “liquid air” battery has a capacity of 50MW or 250MWh over a five-hour release time. It follows the success of a 5MW pathfinder project built next to a landfill site at Pilsworth near Bury, in summer 2018 with £8m of funding from Innovate UK.

Augmented reality set to bridge the visualisation gap

Network Rail has contributed its design data to an app that enables passengers to use augmented reality (AR) to see what proposed replacement footbridges at stations will look like when complete - with the app bringing architects designs directly to passengers’ smartphones.

The new app will support Network Rail’s engagement with passengers while delivering footbridges across the network throughout Control Period 6 (1 April 2019 to 31 March 2024) and beyond.

Demos report: Value Added - how better government procurement can build a fairer Britain

The government should use its significant procurement spend to bring about a fairer economy and give more opportunities to SME firms, especially when appointing external suppliers, says a new report by Demos. With current spend on external suppliers at £284bn, procurement is the UK government’s largest expenditure, equal to 13.4% of the UK’s GDP. Influencing how this money is spent represents a significant opportunity for government to shape the nature of business and the wider economy, says the report, which looks at how central government could use public procurement more strategically to bring about a fairer economy and more efficient, effective government.

£640m flood scheme set for final investment

The largest-ever investment in a UK flood-protection scheme is set to take place, as a key funder announced it would approve its share of the £640m package. Surrey County Council announced its intention to formally agree a £270m contribution to the River Thames Scheme, which is designed to reduce the flood risk to 15,000 properties. The scheme will create three flood-alleviation channels alongside the River Thames and improve capacity at three weirs. It will run from Datchet in Berkshire through Surrey to Teddington.

KPMG: Construction insolvencies rose by 55% in three months

The number of construction firms falling into administration rose by over half during the third quarter of the year. According to KPMG restricted access to finance, rising input prices and project delays caused by political uncertainty have started to take their toll. Administrations in the sector jumped up from 49 in the second quarter to 76 in the third quarter of this year.

CECA Welcomes Publication Of Rail Enhancements List

The UK Government has published the Rail Network Enhancements Pipeline (RNEP), showing upcoming rail upgrades for the coming five years. The update supplies information on the RNEP schemes being funded by the Control Period 6 (CP6) enhancements budget. The CP6 budget covers 2019 to 2024.

For each RNEP scheme the Department for Transport only commit to the next stage of development. Schemes being created are listed within Network Rail's Enhancement Delivery Plan.

RIS2 Update

In less than a year, the government's Road Investment Strategy 2 (RIS2) will commence.

Starting in April 2020 and running for five years, this investment period will deliver important road schemes set out by Highways England and the government.

Continuing the work from the inaugural Road Investment Strategy, the investment will be more than ever before, eclipsing the previous £15 billion funding by more than £10 billion.

CECA Publishes New Dayworks Schedules

The Civil Engineering Contractors Association (CECA) has published a new version of the Schedules of Dayworks Carried out Incidental to Contract Work, the standard industry contract for the construction of infrastructure schemes.

The new two volume version can be used for either, i) pricing of work undertaken on a daywork basis where no other schedules are included with contract documentation, using volumes 1 & 2, or ii) pricing of standalone projects where appropriate, using only volume 2.

The new titles are Volume 1 - Schedules of Dayworks Carried Out Incidental to Contract Work Including Rail Equipment Items and Volume 2 - Schedules of Contractors Equipment Rates for use on Construction Contracts Including Rail Equipment Items.

Rates and prices included in Vols 1 & 2 of the Schedules apply to work carried out on a Daywork basis on or after the date of publication. Equipment rates have been recalculated to reflect current costs and rail equipment items have been included to fully reflect the range of works undertaken.

The publication is available from CECA at 1 Birdcage walk, London SW1H 9JJ and cost £20.00 to CECA members and £45.00 to non-members. It is available to buy online in hard copy only.

Commonwealth Games contractors to be appointed in early 2020

Proposals have been submitted by Birmingham City Council to its planning department for the £72m revamp of the city's Alexander Stadium. The stadium, part of the wider £500m Perry Barr regeneration, is set to be a focal point of the Birmingham 2022 Commonwealth Games as it plays host to athletic events and the opening and closing ceremonies. If plans are approved, contractors will be appointed in early 2020, with work set to start next spring and complete in late 2021 ahead of test events. The Commonwealth Games takes place in July 2022.

Labour pledges five-fold increase in offshore wind capacity

The Labour Party has pledged a five-fold increase in offshore wind and the creation of nearly 70,000 jobs. Labour leader Jeremy Corbyn made the pledge while visiting MHI Vestas's wind turbine logistics facility at the old Fawley power station in Southampton. During the visit, Corbyn outlined Labour's ten-year plan for clean energy to reduce emissions to net zero and keep global temperature rises to 1.5 degrees. The plan would mean a five-fold increase in the UK's offshore wind capacity, with 37 new wind farms, as part of a "green industrial revolution" that would help to tackle the climate emergency, create new, good unionised jobs and invest in coastal communities.

The new investment - drawn from a combination of public and private sources and worth £83bn over ten years - is estimated to create more than 67,000 new jobs across the country and provide enough electricity for 57 million households, replacing the need for 38 coal power stations.

Procurement pilots set to save contractors and supply chain SMEs £25m

CITB and construction employers are piloting four schemes to improve procurement practices for homebuilding and infrastructure projects set to achieve £25m savings. The Improving Performance Through Better Procurement Approaches commission will see just under 12,000 construction workers trained, half of which to be from small and medium-sized enterprises (SMEs), within the housing, infrastructure and local authority-led construction sectors in England, Scotland and Wales.

The four pilot projects are set to receive £3m in funding in total, but are expected to achieve £25m in savings, involving 1,900 construction employers and focusing on collaboration to mitigate risk, as well as an emphasis on quality and whole life outcomes, not just time spent.

CITB: Construction needs breathing space on post-Brexit visas

Construction employers want greater simplicity and a breathing space on planned visa restrictions following the UK's departure from the EU, according to a new report from the CITB.

The research report, Migration and Construction, finds that just 3% of construction employers have the necessary experience in handling visa applications, with two-thirds saying that the process is difficult. Under the new post-Brexit immigration system - due to be introduced in January 2021 - employers will have to learn how to manage visa applications for EU workers. Any system that makes the hiring of migrant workers too bureaucratic, says the CITB, threatens to block the work pipeline, including the government's homebuilding and key infrastructure ambitions.

Department for Transport: 18 new roads move a step closer to completion

A first wave of funding announced has been which will enable 18 new road schemes to move on to the next stage of development. They include £31 million for the Preston western distributor scheme: a new dual carriageway link between the M55 and the A583 is designed to improve travel between the enterprise zone at Warton and the Springfields nuclear facility at Salwick, as well as reduce congestion in Preston and directly lead to the creation of 3,575 houses and the creation of over 500 jobs. Through the Lancashire County Council funded link road, a further 1,745 houses will also be built.

CECA: Crossrail 2 Planning Funds “Very Welcome”

CECA has said recent reports that HM Treasury’s spending round for the next financial year contain £6 million allocated to the Department for Transport to develop plans for Crossrail 2 as “very welcome.” This follows that Chancellor’s Spending Round earlier this month, in which the Government promised an “infrastructure revolution” and “continued support for the development of major transport projects, including pushing on work on the Leeds to Manchester route of North Powerhouse Rail, and driving forward East West rail links in the Oxford to Cambridge Arc.”

Green light for £90m gas-fired power station

An application to build a £90m gas-fired power station has been approved by the Department for Business, Energy and Industrial Strategy. Consent has been given for the plant, located on Abergelli Farm, north of Swansea, south Wales, and connected infrastructure with a generating capacity of up to 299 MW. Drax submitted an application to the Planning Inspectorate for consideration earlier this year, and after consideration of its assessment, the government has given it the go-ahead.

£62m released for 13 flood defence projects

Thirteen flood defence projects across Yorkshire, Cumbria, the North East and the South East will receive £62m of central Government funding. Many of the projects are located in communities that suffered from flooding during winter 2015, with over 9,000 homes due to benefit from improved defences. The extra funding is in addition to the government’s commitment to invest a record £2.6bn over six years up to 2021 to better protect 300,000 homes across the country.

Funding will support the development of 11 projects in the Northern Powerhouse, including seven in Yorkshire, four in Cumbria and Lancashire and two in the North East.

In the NW, the projects are at Egremont, Flimby, Kendal and Preston/South Ribble.

Common Challenges, Shared Response: new report on digital maturity in UK infrastructure sector

A new report by the Digital Transformation Task Group has been published, providing a data-driven snapshot of digital maturity from the UK’s Infrastructure Client Group. Titled Common challenges, shared response, the report prepared by Mott MacDonald and sponsored by the Infrastructure Client Group and Institution of Civil Engineers, identifies best practice from the ICG and highlights areas where collective action is needed to remove blockers and accelerate progress across the energy, transport and water sector.

Highways England to launch £400m resurfacing framework

Highways England will open a £400m framework for resurfacing concrete on its Strategic Road Network (SRN) after “critical failures” and safety concerns on roads over the last three years. The government body is looking for contractors to develop a “comprehensive response” to the safety risks on legacy concrete, which is exposed or worn down, according to the OJEU notice. The works will be divided across four lots for testing, design, repair and maintenance, and renewals, and will take place between 2020 and 2025. This phase of works is the second of five road investment periods in an overall £1bn resurfacing scheme, which is set to last until 2051.

Most recently, their investigations resulted in the disqualification of two company directors of CPM group due to their involvement in a cartel. To raise the level of awareness within firms about competition law and the rules with which firms have to comply, the CMA has launched a package of materials to help business. This includes:

Costain starts Preston Western Distributor project

Costain has officially started construction of the £207m Preston Western Distributor scheme for Lancashire County Council. Costain was appointed contractor for the job back in February 2016 on a contract worth £110m. Construction has been delayed by a combination of planning and funding issues. Work is scheduled for completion in 2023.

Bidding underway for £1bn A66 dualling design contract

A £45m contract to design the £1bn transformation of the A66 northern trans-Pennine route is now open for bids. Highways England is developing plans to fully dual the remaining single carriageway sections of the A66 which links the M6 at Penrith in Cumbria and the A1(M) at Scotch Corner in North Yorkshire. The project involves dualling the remaining 18 miles of the 50-mile route.

The MP is a supporter of Small Modular Reactors (SMRs), which are set to be the focus of the conference.

Carlisle extension to Borders Railway making positive progress

Borders Railway trains could soon be travelling down as far as Carlisle, after campaigners for the line extension were told their goal is "moving closer" at their campaign group's annual general meeting. The Campaign for Borders Rail (CBR) have been campaigning for the Carlisle extension for number of years, and were told during their meeting by MSP Christine Grahame that their case for extending the line to Cumbria was "rock solid".

Rochdale reveals railway station regeneration

The council will release a masterplan in the New Year for the area around the town's railway station with the potential to provide thousands of homes and commercial space. WSP has been appointed to work up the Station Gateway masterplan, featuring major housing developments along with improved public realm and connectivity to the town centre.

Keighley station set for £4m upgrade

Network Rail has announced an investment of over £4m into the upgrade of Keighley station, improving services and experiences for the 1.7 million annual passengers.

The station building will undergo transformation, as well as the footbridge and entrance, making it brighter and more inviting, whilst protecting its Grade II listed building heritage.

£200m Heysham waste incinerator approved

Veolia has gained planning for a £200m Energy Recovery Facility at Heysham in Lancashire. The energy from waste plant will process up to 160,000 tonnes of rubbish a year creating enough electricity to power 60,000 homes, as well as economic benefits for the local community. Around 350 construction jobs are expected to be sustained during the build programme. The Heysham Gateway project will be built on a 10-acre plot next to Imperial Road near the Lancaster West Business Park.

STAR Procurement: GM Streetscene Alliance update

Procurement for the Alliance contract is now scheduled to begin within 4-6 weeks, with the likelihood of further employer engagement. I will provide further updates as they become available.

St Helens Council to press ahead with £40m Parkside Link road project

Councillors will be asked to endorse plans to press ahead with the £40 million Parkside Link Road project this week. The scheme will see the construction of a new road from the former Parkside Colliery site in Newton-le-Willows to Winwick Lane, adjacent to Junction 22 of the M6 motorway, by-passing congestion at Winwick. Crucially, the road will deliver improved access to the Parkside site, with both St Helens and Warrington councils believing this has the potential to unlock significant development opportunities. In order to facilitate the construction of the link road, several areas of mainly agricultural land have been identified by the council for acquisition. A report set to go before cabinet this week says the total scheme value, including land costs, is £39.8 million. This excludes initial scheme development costs.

Tameside agrees funding deal for 2,350-home garden village

The council has agreed a funding deal with Homes England to bring forward the opening stages of Godley Green garden village, set to bring nearly 2,500 houses to the borough. With a funding agreement now signed off by the council, work on the garden village is in line to begin in early 2021, with construction of the first homes getting under way that summer.

The council has agreed to draw down £10m from the Government's Housing Infrastructure Fund to deliver the opening phases of the garden village, including infrastructure works.

Under a timeline set out as part of the funding, a developer or housebuilder will be picked in May 2020, with an outline planning application for the whole site to following in November that year.

Consultation on £85m Eden Project North begins

Eden Project North has launched a series of public consultation events into its plans for an £85m attraction at Morecambe Bay, as it targets a planning application submission in 2020. Like the Eden Project in Cornwall, Eden Project North would be built in a series of zones aimed at creating an immersive visitor experience.

Region's Green Belt shrinks by 3,400 acres

The North West has seen a loss in designated Green Belt land of 3,410 acres over the past year, according to the Government's latest Green Belt report. The majority of losses came from a combined area of Manchester, Liverpool, and West Yorkshire, which lost 3,237 acres between the 2017/18 and 2018/19 financial years, the second largest loss in the area in the past decade, following a loss of 11,787 acres between 2016 and 2017.

Capita appointed for Carlisle southern link road

A £2.5m contract for design services on Carlisle's £112m southern link road has been won by Capita Property & Infrastructure. The link road is a key priority for Cumbria County Council and Carlisle City Council, which leaders believe is vital in improving east-west connectivity. In February this year Government announced that it would grant £102m from the Housing Infrastructure Fund for the project. The route as mapped out runs west from junction 42 of the M6, meeting the A595 at the Newby West roundabout. The intention is to start construction in spring 2021 for completion in 2023. A six-week consultation was held through June and July this year.

St Cuthbert's Garden Village, where up to 10,000 homes could be delivered, is one of the sites that would be enabled by the link road. Draft options for the village are currently out for consultation.

Transport for the North seeks funds for A595 upgrade

As part of Transport for the North's £700m pan-Northern bid, they are calling for funding to enhance A595 in Cumbria. Working with Cumbria County Council. This important scheme would improve reliability and reduce journey times for residents and businesses.

The North and Midlands 'must take control' to deliver true benefits of HS2 and NPR, says review

A report by the Northern Powerhouse Independent Review into HS2 says the North and Midlands must take control of their high-speed network and that cancelling the major infrastructure project without credible and viable alternatives will not deliver the transformational benefits to the UK economy this country so badly needs. Established to inform the Government-commissioned Oakervee review of HS2, which will report to the Department for Transport on the future of HS2 later this week, the Northern Powerhouse Independent Review:

- Recommends the establishment of HS2 North - a special purpose vehicle working with the private sector to integrate HS2 and Northern Powerhouse Rail (NPR)
- Articulates a 20% increase in the transformational economic impact to the North of delivering NPR along with building HS2, with £1 in every £5 generated from building a new East - West line as a result of long-distance journeys onto HS2
- Warns that only by investing in a new, integrated high-speed network can the historic North-South divide be tackled; upgrades or scrapping HS2 have none of the prerequisites to tackle the UK's geographic imbalance
- Identifies parts of the new and upgraded line network that can be delivered now including connecting Northern cities to each other - the North will not accept waiting until 2040 for HS2 to connect Northern cities to Birmingham, London, Newcastle and Edinburgh

Passengers and freight will see improvement in Cumbria following major investment

Just under two miles of worn out track will be removed and replaced between Drigg and Bootle as part of the £2.8m Great North Rail Project. This includes the upgrading of railway stone and drainage.

Funding secured for Irwell bridge

The Hawkins\Brown-designed bridge, linking New Bailey in Salford and Manchester's St Johns, has secured funding from the Greater Manchester Combined Authority.

Set run from a plot next to Manchester's The Factory arts centre, currently under construction, and New Bailey, the bridge will provide a cycling and walking route over the Irwell to connect the two rapidly developing areas.

Mayfield vision unveiled as plans go in for £1.4bn transformation

The Mayfield Partnership has put forward the first phase of its £1.4bn masterplan next to Manchester's Piccadilly station, featuring a 70,000 sq ft office and the city's first public park for more than a century. The opening phase of the wider masterplan is to feature the 6.5-acre public park around the River Medlock with a 70,000 sq ft speculative office alongside. There will also be a 545-space multi-storey car park delivered as part of phase one.

Government overrules planners for Drax gas power station

More than 800 construction jobs will be created at the Drax power station after the Government overruled the planning inspectorate to give permission to build four new gas turbines at the site near Selby. It is also proposed to construct up to two battery storage facilities, one per generating unit and each up to 100MW. A new gas pipeline will be built to connect to the existing National Transmission System pipeline 3 km to the east across largely agricultural land. The new gas plant would be engineered to allow carbon capture equipment to be fitted in the future.

Jake Berry: Problems for Bradford if Manchester's £6bn underground station is built?

Bradford may not get a city centre station on the proposed Northern Powerhouse Rail route if a £6bn underground site is built to accommodate high speed rail in Manchester.

Route selected for new River Dee Bridge

A route has been confirmed for the new plans to the River Dee's new A494 bridge between North Wales and the North West of England after 12 weeks of deliberation. The Welsh Transport Minister, Ken Skates, announced that the upgraded bridge would take the new route in a statement which detailed a new river crossing for westbound traffic and the partial reuse of the existing River Dee Bridge for eastbound traffic. The new bridge will consist of a new offline carriageway for westbound traffic which will be composed of three lanes and a hard shoulder, which will extend from the River Dee to the Queensferry junction, minimising any disruption during the construction process through maintaining a steady flow of traffic. Furthermore, the new bridge will include cycle paths and pedestrian paths so as to encourage alternative, and environmentally conscious, modes of transport while also improving links within business zones. Construction is predicted to commence in 2021 after the finalisation of designs and following a public exhibition process.

Amey/McAlpine green light for M6 junction 19

A joint venture between Amey and Sir Robert McAlpine has got the green light to transform a key motorway junction in Cheshire. Work will get underway next year after the JV signed off a £35.5m design and build contract to remodel junction 19 of the M6, near Knutsford. The project involves building a new bridge through the existing roundabout and over the M6, creating a better flow between the motorway and the A556.

Peel progresses Protos plant

Working with energy provider Waste2Tricity, Peel Environmental has put forward a planning application for a plastics-to-hydrogen facility at the 133-acre site near Ellesmere Port. The £7m facility is said to be the first of its type in the UK to use advanced thermal treatment technology developed by PowerHouse Energy Group, which is based at Cheshire's Thornton Science Park.

Plans progress for new waste-to-energy plant in Preston

Plans for a £200 million waste-to-energy plant on the outskirts of Preston, UK, have moved one step closer to fruition. Preston City Council's planning committee voted not to object to the proposals put forward by infrastructure development, asset management and investment company Miller Turner. The firm plans to build the plant at Red Scar industrial estate. Lancashire County Council's development control committee will make the final decision on whether the facility can be built.

£120m plan to replace Liverpool flyover with tunnel

A £120m plan to radically redesign Liverpool's Rocket junction at the M62 has been submitted to the Department for Transport. Transport for the North has included Liverpool City Council's scheme as one of four major projects within a £700m programme of works identified as critical to growth in the north of England. The major upgrade to the Rocket Junction would see the existing Queens Drive Flyover demolished and replaced with a new roundabout and dual-lane underpass.

Crewe HS2 hub consultation gets under way

Cheshire East has launched two consultations for the future of Crewe station, including options for a road bridge and the potential to bring forward up to 3.8m sq ft of commercial space along with 3,700 homes. The first consultation focusses on the area action plan, an area which stretches from Basford Hall sidings, across Weston Road to Second Avenue; along Gresty Road, South Street and Mill Street; and as far as Manchester Bridge along the A532.

EA: £220m marine and coastal defence framework

The Environment Agency has named the contractors it will use to deliver a £220m programme of marine and coastal flood defence work. Work has been split into two lots on the new framework, one covering major projects valued from £5m-£50m and the other smaller jobs worth less than £5m. The new arrangement will run until March 2023.

£500m Sellafield DDP framework extended to 2026

Sellafield has extended contracts to 2026 with seventeen firms it selected three years ago to deliver its £500m clean-up programme in Cumbria. So far the six alliances and joint ventures on the Decommissioning Delivery Partnership have delivered £385m worth of work and recorded 4.5m hours without a lost-time accident. The future pipeline projects include completing demolition of the infamous 110m tall Windscale pile chimney, scene of Britain's worst nuclear accident, and clearing land and removing the heat exchangers around the redundant Calder Hall reactors and turbine halls. The firms will help to plan the dewatering of the pile fuel storage pond and clean up the large Thorp and Magnox reprocessing plants.

Concrete roads can charge electric cars

Concrete roads that charge electric vehicles could transform the way we travel. Inductive charging is where the EV battery is charged without the need to plug the vehicle into a charging point. The process is wireless and can be done whilst the EV is on the move or stationary. Research projects around the world are already pioneering the technology. Belgium-based Flanders Make has tested the installation and use of inductive charging systems in concrete and asphalt roads.
