I was especially pleased that, after a two year wait, CECA NW was able to hold its annual awards dinner in October. It was great to meet colleagues and friends again, and that the dinner was so well attended with over 300 people present. My congratulations go to the winners of the CECA NW 2021 Awards: Cheetham Hill Construction for Project of the Year under £1 million; Aggregate Industries together with A E Yates for Project of the Year between £1-5 million; Cubby Construction for Project of the Year over £5 million; George Cox & Sons, Bethell Construction and Tarmac for the Collaborative Partnership Award; Graham Construction for the Social Value Award; Emma Hafford of ACS Construction for the Women in Civil Engineering Award; Jordan Smith of D Morgan plc for the Young Professional of the Year. And the Lifetime Achievement Award went to three eminent civil engineers: Ian Spurr of I&H Brown; Geoff Absalom of George Cox & Sons; and Colin Briscoe of Colin Briscoe Construction.

I am delighted to welcome DSD Construction into membership, and we are all set to announce further new members of CECA NW.

We are working closely with clients, and recently arranged sessions with Sellafield Ltd and Liverpool Combined Authority, and are currently assisting Network Rail NW&C with its forthcoming supply chain conference. Further client liaison meetings will be arranged and publicised accordingly.
