
Grant Scheme changes

Industry Impact Fund

- £3 million (projects up to £500,000)
- Deliver benefits for the wider industry
- Productivity, Equality, Diversity and / or Inclusivity
- Impact, Sustainability, Scalability and ROI
- Must be endorsed
- 3-month assessment round
- Launch date is 3rd April 2023





Employer Network

- 12 month initiative set up and funded by CITB, run by local or sector specific network groups
- Aims to simplify the way you get the support and funding you need to access the training you want
- Because the employer networks are organising it all there's no CITB form to fill in to apply for grant
- 2 sector specific networks and 5 local pilots (including CECA)
- SW Employer Network covering Swindon and Wiltshire
