The Civil Engineering Contractors Association (CECA - pronounced 'see- ka') is the foremost representative body for civil engineering contractors in the UK.

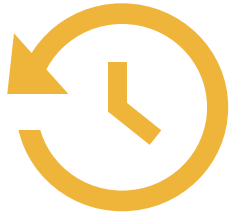
CECA was established in 1996, but its provenance stretches much further back as it was born out of the Federation of Civil Engineering Contractors, which was first established in 1919.

CECA members range from the largest infrastructure companies in the UK to smaller specialist SMEs. 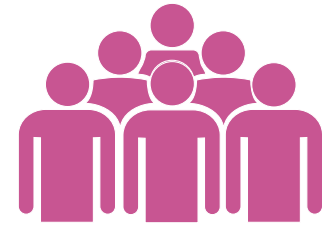

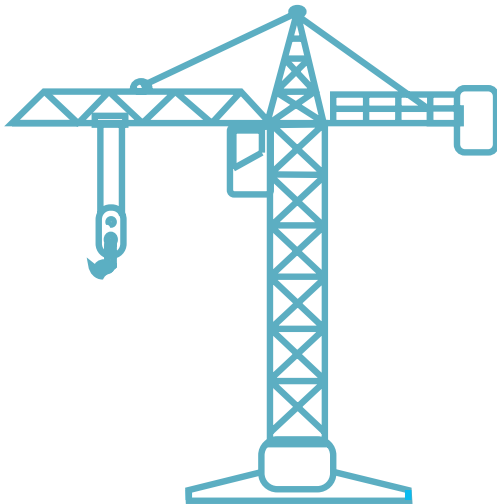

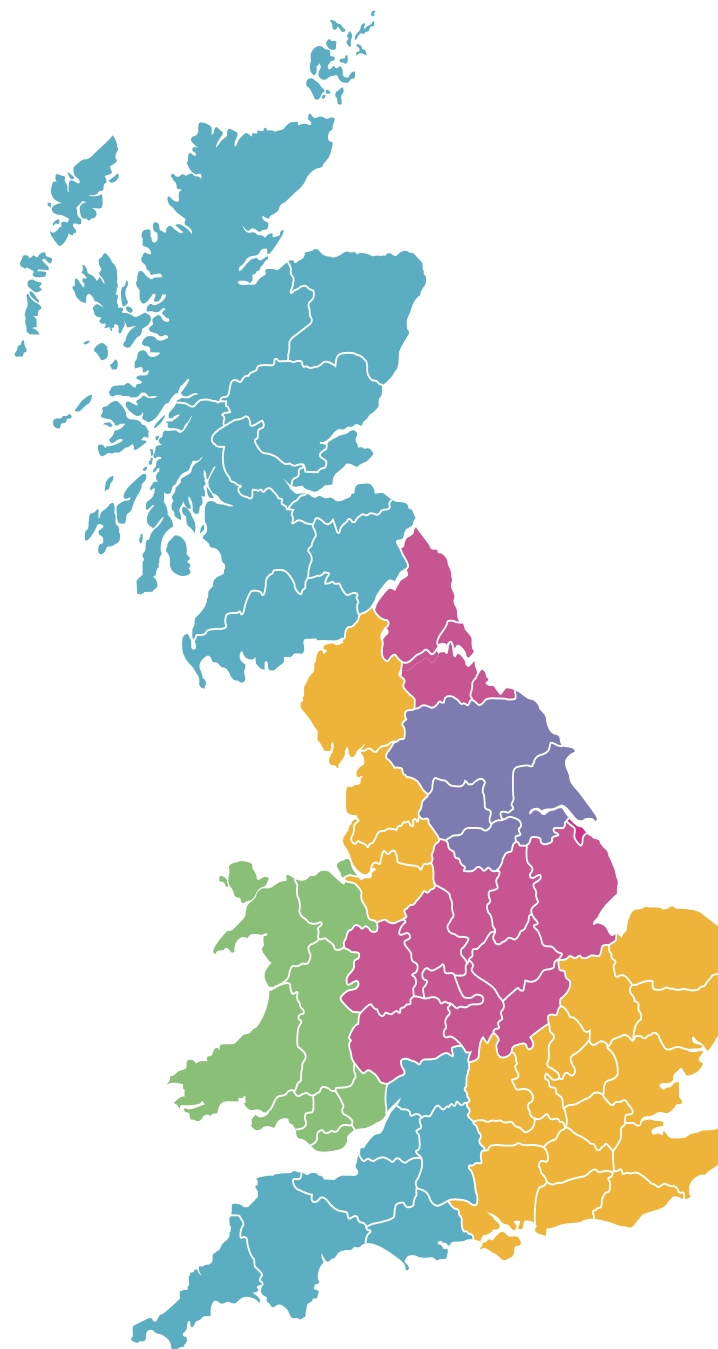


REGIONS & DEVOLVED NATIONS

CECA POLICY

CECA's policy office at the heart of Westminster provides an overview and influences government on behalf of members and the civil engineering industry. CECA (Scotland) and CECA (Wales) maintain close links with parliamentarians in the devolved administrations of Holyrood and Cardiff.

Core priorities include:

Representation

- We develop and maintain close relationships with clients, government and the media

- We ensure that government policy develops in a way that positively supports the interests of members
- CECA sits on the Construction Leadership Council & is represented on CIJC
- We meet regularly with elected politicians, as well as key opposition MPs, civil servants, and other industry stakeholders.

- We work with organisations to ensure members have the best opportunities to benefit from available training funding
- We lobby to ensure both national and local governments take steps to address the skills gap, attract new entrants to our industry, and upskill the workforce
- We support the delivery of the industry's Fairness, Inclusion and Respect programme
- We support negotiations for the Working Rule Agreement and ensure CECA member companies are heard in negotiations at all levels of industry.

Health & Safety

- We are part of the Health & Safety Executive's Construction Industry Advisory Network (CONIAN)

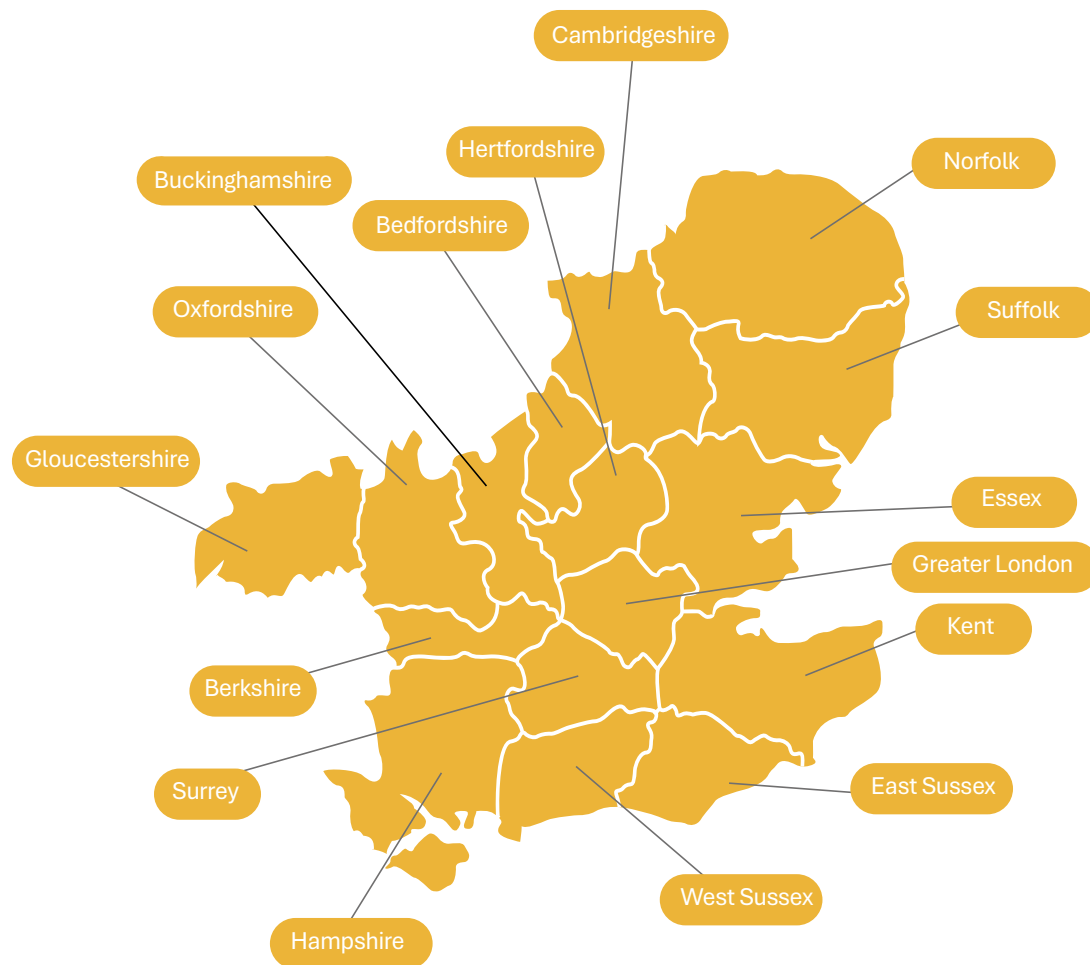

CLIENTS, POLICY & WORKLOAD

Clients, Policy & Workload focuses on ensuring a sustainable pipeline of infrastructure projects by fostering strong relationships with clients and policymakers. Through advocacy and strategic collaboration, CECA represents members' interests on procurement, fair payment, and regulatory frameworks. This pillar also monitors market conditions and supports visibility of future workloads, helping civil engineering contractors plan effectively. By aligning industry needs with government strategy, CECA drives a stable and productive environment for delivering national infrastructure.



SUSTAINABILITY & SOCIAL VALUE

CECA's work in the sustainability and social value space ensures that our members are positioned to implement sustainable practices across the sector, decarbonising operations, and increasing the social value of the schemes that they deliver. In particular, this involves aligning with the Construction Leadership Council's CO₂nstructZero programme, which is working to ensure industry moves towards a net zero future, eliminating diesel use on sites, adopting new technologies and solutions, and engaging in co-ordinated collective action to meet the climate crisis.



HEALTH, SAFETY & WELLBEING

Through engagement with schools, colleges, and industry partners, CECA promotes rewarding career pathways and diverse opportunities. The organisation supports members with resources and campaigns to address skills shortages and increase workforce diversity. By championing inclusive recruitment and skills development, CECA ensures the sector is equipped to deliver future infrastructure and remain competitive in a changing world.



SKILLS & TRAINING

CECA's core pillar Skills & Training focuses on ensuring the civil engineering sector has a highly skilled and future-ready workforce. CECA supports members by promoting lifelong learning, upskilling opportunities, and access to quality training programmes. Through collaboration with industry and education partners, CECA helps shape a training landscape that meets evolving needs. This pillar plays a vital role in closing skills gaps, supporting apprenticeships, and fostering innovation - ensuring the workforce is equipped to deliver the UK's infrastructure ambitions effectively and safely.

HOW TO JOIN

Membership has two defined routes: Full and Associate.

Full members are deemed to be civil engineering contractors or have within their business profile an element of civil engineering activities as set out in the full member application form. Full membership provides access to the complete range of products, services and support available from CECA. Full CECA Southern members, where their work is geographically spread, can also attribute a proportion of the subscription to an additional region/s so that they are able to access the local services of that region.

Associate membership is open to companies who work in association or on the peripheries of civil engineering contracting and wish to contribute to the industry and exchange mutual understanding, knowledge and expertise. We welcome applications from well-intended companies, however the selection process is rigorous and associate members do not have the same rights as full members.

FULL MEMBERSHIP

The CECA Southern Ltd Board review the suitability of companies applying for Full Membership - their decision is final and without recourse. Prospective applicants to become full members of CECA Southern should:

- Be registered in the UK as a limited company with a civil engineering turnover of at least £500,000 per annum.

- Have a registered office in the geographical area of CECA Southern.
- Be registered for VAT.
- Be registered with CITB.
- Be engaged in Civil Engineering.
- Have traded for at least 3 years as a Civil Engineering company.
- Have at least one qualified Civil Engineer.
- Have a Quality Assurance System in place.
- Have compliant Health, Safety & Well-being and Environmental Policies.
- Have at least 60% of workforce with CSCS or equivalent cards.
- Conform to the general principles of the CIJC Working Rule Agreement and have Contracts of Employment for all employees.
- Adhere to the CECA Code of Conduct.

ASSOCIATE MEMBERSHIP

The following applies to prospective applicants for associate membership of CECA Southern:

- Be registered in the UK as a Limited Company.
 - Have a registered office in the geographical area of CECA Southern.
 - Carry out business activities closely allied and supportive of the civil engineering industry.
 - Be registered for VAT.
 - Be registered with CITB, if in scope.
 - Have traded for at least 3 years.
 - Adhere to the CECA Code of Conduct.
 - Have a Quality Assurance system in place.
 - Have compliant Health, Safety & Well-being and Environmental Policies.
 - Conform to the general principles of the CIJC Working Rule Agreement and have Contracts of Employment for all employees.
 - Associate Membership specifically excludes any rights to influence or amend existing constitutional matters or the manner, operations or policy of CECA Southern.
 - Associate Members are expected to contribute to, and benefit from, the mutual exchange of information and expertise with CECA members and thereby broaden and enhance the mutual understanding of the needs and priorities of the industry.
- Associate Membership must never be sought or regarded as a platform or access route to CECA members for marketing purposes. Any Associate Member exploiting membership for such purposes will have their membership terminated forthwith.
 - CECA Southern welcomes input and initiatives from Associate Members in furtherance of Safety, Welfare, Environmental and Technical Development issues and will be pleased to support such initiatives as appropriate.
 - Associate Members will be entitled to attend and participate in all CECA Southern seminars, training courses and social events, but will not be eligible to join the CECA Southern Board. Associate Members may, however, be invited to attend and to contribute to the CECA Southern Ltd Board on matters of specific relevance and expertise.
 - Applications for Associate Membership must be accompanied by a paper setting out what benefits the applicant can bring to CECA Southern and their expectations of the benefits they will receive from membership.
 - Applications must receive approval by the CECA Southern Ltd Board.

CODE OF CONDUCT

We maintain a code of conduct that we expect our members to comply with; these have been written by our members and endorsed by the CECA Southern Ltd Board. These are that members should:

- Acknowledge the advantages of trading relationships being conducted in a fair and transparent manner.
- Recognise the confidence that is engendered by collaborative working by all members of the supply chain together with the promotion of a culture of mutual trust, which benefits all participants and the client.
- Treat their own supply chain fairly & equitably by choosing and negotiating forms and conditions of contract with equal treatment for all, and which identify, assess and allocate risk fairly.
- Commit to ensuring that all payments for work undertaken throughout the supply chain are paid when due.
- Provide and maintain a safe working environment for all, taking account of the CECA Health and Safety Action Plan and Strategy.
- Undertake any project with a responsible attitude toward the environment, the local neighbourhood and sustainability issues.
- Endeavour to meet the CECA aspiration of a 100% fully qualified workforce.
- Work with, and provide sufficient and accurate information to, supply chain partners in an open, fair and collaborative manner:
 - promoting the benefits of team-working.
 - establishing clear and effective lines of communication.
 - providing and encouraging early involvement of relevant supply chain partners to discuss client requirements and identifying solutions.
- Work together to deliver projects in accordance with an agreed programme within time, budget and standards of quality by sharing information on progress and establishing systems for monitoring and reporting performance.

Large multinational companies without current turnover in the UK – fixed introductory fee of £12,000.

SUBSCRIPTION

Membership runs from January - December each year. (Applications can be made at any time during the year and charged on a pro rata basis.)

Full membership subscription is collected in a fair and equitable manner to reflect the size and turnover of each member company.

Where members indicate that they are operational in other regions/ nations the single subscription can be apportioned internally by CECA so that they can access the other region's services and no additional subscription fee is required.

Maximum subscription fee-paying members get automatic CECA coverage across the UK.

Each individual Full member is deemed to be a member in their own right (irrespective of any member holding/owning company or association with any group of companies). If the company can prove

they are part of an existing member group/owning company they will be entitled to a 10% reduction off the standard subscription fee when **one or both** of the following criteria apply:

- Has a separate brand and identity from its holding/owning group
- Competes for business in its own right and in its own name

The turnover for Full membership is derived from the annual turnover from the company's last set of audited accounts for civil engineering as defined below:

Roads, Bridges, Drainage, Sewerage, Sewage Works, Piling, Sheet Piling, Foundations, Coastal Defence/ Protection, Marine Engineering, Bulk Earthworks, Remediation, Highway Maintenance, Surfacing, Telecommunications, Ducting & Cabling, Pipelines, Pumping Stations & Mains, Rail, Private Sector Infrastructure & Groundworks, Reinforced Concrete Structures, Tunnelling, Pipe Jacking, Cofferdams and Caissons and Specialist Civil Engineering Services.

Bands and membership fees:

Turnover up to £2.7m - £1,261 Fixed Fee

Turnover Between £2.7m - £66.7m – Calculated at 0.04671%

Turnover Above £66.7m - £31,156 (Maximum fixed fee – UK coverage)

Associate membership is a fixed fee at £1,500 + VAT per region.

**Please note a 6 month notice period is required from any member wishing to terminate membership.*
